**Andrew Mendonsa: SC member:** April is Alcohol Awareness Month. We have great things going on in regards to our prevention providers in the schools and communities getting information out about the dangers of underage drinking and ways to get treatment and services. We are excited to be sponsoring a virtual Fentanyl Town Hall on April 26, 2022. Fentanyl deaths continue to rise; we are seeing an unprecedented amount of deaths in Sacramento County compared to last year and the previous years. We are also seeing increased deaths in the younger age population. We are collaborating with the District Attorney's office and a variety of partners in the community to get supplies of Narcan (overdose reversal agent) out to our community as quickly as possible.

This month is also Drug Take Back Month. There are a lot of [take back locations](#) / drop boxes at pharmacies around town that are secure where you can take unused or expired medications back and get them out of the house. When homes are robbed, prescription drugs are stolen and enter the drug stream out in the streets, so we want to try to keep those as secure as possible.

**Lilyane Glamben, ONTRACK Program Resources:** ONTRACK Program Resources has been awarded a Behavioral Health Justice Intervention Services grant to launch the Community Health and Justice Project (CHJP). The goal of the CHJP is to transform the way Sacramento's criminal justice, behavioral health and stakeholders work together in order to map a strategy to reduce Black/African Americans disproportionality and disparities. Executive Committee / MHSA Updates</b></p>	<p><b>Executive Committee Updates</b></p> <p>Sharon Jennings, Co-Chair, asked those present to submit post-meeting evaluations and shared the update below.</p> <p><u>MHSA Steering Committee (SC) Membership change</u>  Deputy Ronald Briggs's last meeting was last month. We thank Deputy Briggs for his service. Moving forward, Deputy Andrew Swift will represent law enforcement on the Steering Committee. Mi'Shaye Venerable's last meeting was also last month. Thank you for your service, Mi'Shaye. There are several vacant consumer and family member alternate seats available. Please share the application packet with anyone you think might be a good fit.</p> <p><b>MHSA Updates</b></p> <p>Dr. Ryan Quist, Behavioral Health Director, shared the three updates below.</p> <p><u>COVID-19</u>  Sacramento County saw its COVID case rate dramatically decline in March to about 65 new cases per day, but the most recent data shows a slight uptick to about 85 new cases per day. This does not yet appear to be a cause for great concern, but Public Health will continue to keep its eye on this.</p> <p>As a reminder, the second booster shot is available for people 50 years or older or those with a compromised immune system or people who got the Johnson &amp; Johnson shot as their first vaccination.</p> <p>The requirement that we host public meetings virtually has been lifted. We have received substantial public input indicating interest in a hybrid virtual/in-person model for future Steering Committee meetings and are exploring technological options to try to make it possible for people to attend both ways. We will have a survey for SC members to ascertain their comfort level in</p>

See <a href="#">Attachment D – DRAFT MHSA FY2022-23 Annual Update Overview</a>.</p> <p>This Draft Annual Update was posted online for a 30-day period of public review and comment, from April 4 through May 4, 2022. In addition to this presentation to the SC, it will be presented to the Cultural Competence Committee on April 26<sup>th</sup>. On May 4, 2022, it will be presented to the Mental Health Board and the Mental Health Board will conduct the Public Hearing which closes the public comment period.</p> <p>Comments from members of the public can be submitted in a number of different ways. Written or emailed comments can be submitted at any time during the 30-day review period and verbal comments can be provided at the Public Hearing on May 4<sup>th</sup>. 	<p>and the implemented General System Development (GSD) programs served 32,043 unduplicated clients.</p> <p><i>CSS Full Service Partnership Program FY2020-21 Outcomes:</i>            During FY 2020-21, Sacramento County's implemented FSP programs showed considerable progress in reducing negative outcomes and assisting partners to manage their conditions successfully. Changes are represented in percent change from baseline (one year prior to FSP enrollment):</p> <ul style="list-style-type: none"> <li>• Homeless occurrences decreased by 66.4%</li> <li>• Homeless days decreased by 80%</li> <li>• Emergency Room visits for psychiatric reasons decreased by 86.4%</li> <li>• Psychiatric hospitalizations decreased by 51.1%</li> <li>• Psychiatric hospitalization days decreased by 56%</li> <li>• Arrests decreased by 68.3%</li> <li>• Incarcerations decreased by 41%</li> <li>• Incarceration days decreased by 33.5%</li> <li>• Employment rate: Of partners with employment as a goal, 4.3% were working during the FY.</li> </ul> <p><i>CSS MHSA Housing Program Accomplishments:</i>            In FY 2020-21, MHSA funded programs:</p> <ul style="list-style-type: none"> <li>• Housed 374 clients/households who were literally homeless</li> <li>• Served 182 clients/households residing in MHSA-funded apartments</li> <li>• Provided over \$2.1M in rental assistance</li> <li>• Provided over \$2.9M in housing supports/services</li> </ul> <p>Moreover, the MHSA housing portfolio is expanding. There are currently 221 apartments across 10 developments devoted to housing people in MHSA programs. There are 234 more apartments currently planned or under construction across eight developments and BHS continues to explore opportunities for further expansion.</p> <p><b>MHSA Prevention and Early Intervention (PEI)</b>            In Fiscal Year 2020-21, 72,033 individuals were served across Suicide Prevention; 7,165 outreached through Suicide Prevention; 2,810 were served across Strengthening Families; 49,742 trained through Strengthening Families; 304 were served in Integrated Health and Wellness; and 183 outreached through Integrated Health and Wellness.</p> <p><i>Time-Limited Community Driven PEI Grants Program</i>            There are 34 Sacramento County programs funded by the PEI Grants Program for up to two years of operation. These programs are administered by CalMHSA, which also administered the competitive process to select service providers.</p>

	<p><b>Workforce Education and Training (WET)</b></p> <p>The MHSA WET component has the goals of recruiting, training and retaining diverse culturally and linguistically competent staff for the county’s public mental health system. WET funding was time-limited funding, which is now exhausted. Therefore, the county’s WET Plan is currently sustained with CSS dollars.</p> <p>Some of the highlights of current WET programming include: ongoing participation in law enforcement training; two high schools implementing behavioral health curricula (Arthur A. Benjamin Health Professions High School and Valley High School Health Tech Academy); Mental Health First Aid training for community and system partners; Youth Mental Health First Aid training for teachers and school staff; Eliminating Inequities in Behavioral Health webinar series; Mental Health Interpreter Training; Behavioral Health Peer Support Specialist Certification; Psychiatric Residents and Fellowships Training Program; and Central Regional Partnership WET Grant Program.</p> <p><b>Innovation (INN)</b></p> <p>INN provides time-limited funding to test new and/or improved mental health practices or approaches with the goal of increasing access, increasing the quality of services, or promoting interagency collaboration.</p> <ul style="list-style-type: none"> <li>• <i>Mental Health Crisis/Urgent Care Clinic</i> – Adapts the urgent care medical model to provide crisis response/ care for individuals experiencing a mental health crisis. With MHSA Steering Committee support, program services will transition from INN to CSS funding in FY 2022-23.</li> <li>• <i>Behavioral Health Crisis Services Collaborative</i> – Public/ private partnership with Dignity Health which established integrated adult crisis stabilization services at Mercy San Juan adjacent to emergency department. INN project term will end in December 2022.</li> <li>• <i>Multi-County Full Service Partnership (FSP)</i> – Partnership with other counties across California to share and implement new data informed strategies in program design and continuous improvement for FSP programs.</li> <li>• <i>Community Justice Support Program (previously Forensic Behavioral Health Multi-System Teams)</i> – Focuses on justice involved adults (18+) and older adults to increase access to mental health services and promote interagency and community collaboration related to mental health services, supports and outcomes. Project began implementation in March 2022.</li> </ul>

**Capital Facilities and Technological Needs (CF/TN)**

This MHSA component includes two distinctly difference focus areas. The *Capital Facilities* Project was completed in 2015 and the Stockton Blvd complex.

The *Technological Needs* Project is Sacramento's Health Information Exchange, known as SachIE/HIE. It furthers Sacramento County's efforts in achieving the federal objectives of meaningful use of electronic health records to improve client care.

Dr. Kasirye moved that MHSA Steering Committee support moving forward with the Annual Update, with the correction made to INN 5 project name. The motion was seconded by Judge Borack.

**Public Comment**

**Stephanie Ramos, Cal Voices:** The SC should look at the Time Limited PEI grants funded through CalMHSA that will be ending in May. Many of them are going to small, grassroots organizations that would not have been able to apply for funding in a more traditional process. The SC should determine if the programs funded by these grants have proved valuable and whether Sacramento County should continue funding them using other funding streams within MHSA.

	<p><b>Dr. Diane Wolfe, psychiatrist:</b> INN 3 Behavioral Health Crisis Services Collaborative is an important program doing valuable work. The SC voted to end funding to Mercy San Juan due to concerns regarding provider discrimination, but with the understanding there would be a search for an alternative provider. It would be a bad decision to just let that program die.</p> <p>Program success stories are wonderful, but it would be valuable to also include failures/challenges (wait lists, etc.) to better identify what the needs are vs. what is offered.</p> <p><b>Nancy Brynelson, family advocate:</b> I agree with the suggestion made earlier to revisit the question of MHSA funding for AOT services. That program will begin July 1, 2022, and when it came before the Board of Supervisors, DHS Director Chevon Kothari spoke about the possibility of using MHSA funding for that program. However, the presentation spoke more about the past than what would happen in the future or what that program would look like. As one of the family representatives supporting AOT services, we welcome investigation of all funding sources for those services.</p> <p><b>Mary Ann Bernard, family advocate:</b> What we need to talk about is not what is in the plan but what is not (e.g., AOT). I continue to have questions regarding the mandate in <a href="#">California Welfare and Institutions Code section 5813.5(f)</a> to provide services similar to those established pursuant to the Mentally Ill Offender Crime Reduction (MIOCR) Grant Program. I have looked for services like these in this plan and do not see them. There is an ongoing crisis for persons adjudged Incompetent to Stand Trial (IST) and I am disappointed I do not see any services such as these in this Annual Update.</p> <p><b>SC Action</b></p> <p>The MHSA SC voted unanimously in support of moving the MHSA Annual Update forward, noting the comments and feedback discussed.</p>
<p><b>VII. General Steering Committee Comment</b></p>	<p><b>Leslie Napper:</b> I am excited for the Safe Black Space 4<sup>th</sup> anniversary. Information can be found at: <a href="https://www.safeblackspace.org/">https://www.safeblackspace.org/</a></p>
<p><b>VIII. General Public Comment</b></p>	<p><b>Stephanie Ramos:</b> Peer certification will begin with a grandparenting process in May. Initial certification will likely start in January 2023. CalMHSA and counties are working together to provide scholarships to peers within the county for trainings, exams, and certification fees. Cal Voices has been approved to be a training program through CalMHSA for peer certification. 

**Announcing Behavioral Health Justice Intervention Services (BHJIS) grant award  
to launch the Sacramento Community Health and Justice Project**

ONTRACK Program Resources is proud to announce it has been awarded a *Behavioral Health Justice Intervention Services (BHJIS)* grant to launch the *Community Health and Justice Project (CHJP)*. CHJP will transform the way Sacramento's criminal justice, behavioral health and community stakeholders work together in order to map a strategy to reduce Black/African Americans (Black) disproportionality and disparities.<sup>1</sup>

A system change plan to improve outcomes for Black people involved in the Sacramento criminal justice and behavioral health systems will be collaboratively developed through the *Collective Impact* approach which brings people together in a structured way to achieve social change. *Collective Impact* strategically creates a network of community members, organizations, and institutions who advance equity by learning together, aligning, and integrating their actions to achieve population and systems level change.<sup>2</sup>

CHJP *Collective Impact* will include a steering committee and work groups consisting of Sacramento Black community stakeholders (with lived experience with criminal justice and behavioral health issues) and local agency partners (i.e., Behavioral Health Services, Police, Probation, Sheriff, Public Defenders, Mayor's Office, etc.). The BHJIS grant includes funding to compensate Black community members with lived experience for their participation as subject matter experts in the *Collective Impact* decision-making process. Additionally, ONTRACK will conduct focus groups and key informant interviews, agency utilization data collection and analysis specific to Black people that has not been previously synthesized in Sacramento County; provide trainings; conduct community outreach and stigma reducing communications; and engage in other broader community engagement methods.

CHJP will leverage and build upon ONTRACK's *MHSOAC Sacramento Black Community Mental Health and Criminal Justice Real Talk* event that took place in fall 2021 ([www.getontrack.org/realtalk](http://www.getontrack.org/realtalk)).

The BHJIS grant program provides funding through 02/14/23 from the California Department of Health Care Services (DHCS) and is administered by Advocates for Human Potential, Inc. (AHP) ([www.co-responding.buildingcalhhs.com](http://www.co-responding.buildingcalhhs.com)).

<sup>1</sup> **Disproportionality:** The percentage of a certain racial or ethnic group as compared to the percentage of the same group in a system. For example, Blacks/African Americans in Sacramento County make up approximately 10% of the overall population but more than 20% of public behavioral health and 30% of criminal justice systems involved populations.

**Disparity:** Unequal treatment when comparing a racial or ethnic minority to a non-minority. This can be observed in many forms including decision points, treatment, services, resources, or the likelihood of being arrested, admitted to detention, admitted to facilities and voluntary agencies, and in care. <https://ocfs.ny.gov/main/recc/disparity.php>
