VIII. General Public Comment	<p>Mary Ann Bernard: I am a lawyer, mother of a severe mentally ill young man, and an advocate for the severe mentally ill. Sacramento County is serving many people under the MHSA Prevention and Early Intervention statute; however, the focus of these programs should be on those individuals with a diagnosed severe mental illness. Relapse prevention programs to reduce duration of untreated mental illness and assistance in regaining productive lives for those who have an existing mental illness should be part of PEI programming. Two programs I think would be helpful for relapse prevention is Assisted Outpatient Treatment (AOT) and Community Assistance, Recovery and Empowerment (CARE) Court.</p> <p>Maria Padilla-Castro, Mental Health Board Member: I support the future request to present the Psychiatric Advance Directives to this Steering Committee. We would like your support. Additionally please support the Kaiser strike for the mental health workers.</p>
