Jan 2016	<i>GMC Procurement</i> - Aetna Better Health of California and UnitedHealthcare Community Plan of California are selected.
May 2016	<i>Coverage for All Children</i> - begins. Those in restricted scope Medi-Cal are transitioned to full scope Medi-Cal and interested applicants begin application.
Aug 2016	<i>Health Homes</i> – DHCS announced Health Homes will be implemented no earlier than July 1, 2017 on a staged basis. Sacramento is in Group 3.

Mar 2016	<i>Care Coordination Work Group</i> – decided to proceed with a work group.
Mar 2016	<i>Drug Medi-Cal Organized Delivery System (ODS)</i> - overview provided.
Apr 2016	<i>Care Coordination Work Group</i> – first meeting.
May 2016	<i>Resources</i> – created and posted materials to assist providers and navigators in care coordination including updated member services contact lists, urgent care lists by plan and IPA. <i>New Plans</i> - provided an overview.
Aug 2016	<i>Care Coordination Guides</i> – created for each plan. <i>Data Pull</i> - Plans and County Mental Health Plan have agreed to a data pull and summaries to inform process. <i>Hospital Emergency Room Data</i> - All hospital systems provided data including avoidable primary care.
Sep 2016	<i>Universal Release of Information (ROI)</i> – began discussion of need for care coordination.
Oct 2016	<i>Data Summary</i> – Each plan presented on data of high non-primary care utilizers.

Care Coordination

- Create tools (such as other materials, flow pathways, etc.)
- Create strategies
- Share best practices.

Information Sharing

- Care Coordination Release of Information (ROI)
- Health Information Exchange

Address cross system coordination issues for individuals with:

- Mental health needs
- Substance use disorders
- Homelessness
- Criminal justice involvement

Drug Medi-Cal Status

Prepare for new Plans (e. g., updated status, default algorithm, materials, etc.)

Prepare for the Health Homes Program (HHP)

- Implement what is possible now.
- Align current and proposed practices with HHP requirements.

Data

- Finalize Health Plan data reports (content, frequency) to assist in planning efforts.
- Process for Health Plans to share utilization data with IPAs/Medical Homes.
- Process for Hospitals to share utilization data with Plans (example: Kaiser/Molina).
- Process for County Mental Health Plan to share information with Plans on a routine basis.
- Periodic hospital reports on ED utilization including avoidable primary care.
- Determine relevant data indicators for success.
