### In response to questions from members:

- Who do you contact for MH services? There are two managed care resource guides posted on the webpage for access to behavioral health services (either through health plans or County Mental Health Specialty). There has been no change in County Mental Health Specialty Services. The MH Benefit expansion is on the health plan side. Member services numbers are listed for plans. County MH has an Access Team. Also see Managed Care PPP Overview.
- What services are in the Primary Care Center? The Primary Care Center building has a number of small clinics. All of which have grown smaller due to the transition of medically indigent into expanded health care coverage programs. Planning is in process to merge at least one of the clinics and to accommodate an increased volume in Refugee Health Assessment Clinic. Services in the PCC include:
  - Indigent Clinic – now seeing mostly uninsured with medical need for eligibility and linkage to a medical home
  - Integrated Behavioral Health (IBH) Primary Care Medical Home – collaboration with UCD Department of Psychiatry and Internal Medicine. Serves assigned Medi-Cal members, adults with co-morbid physical health and mental health conditions, high percentage meet federal definition of homelessness.
  - Refugee Health Assessment – comprehensive health assessment (public health/chronic conditions) for newly arriving refugees; then linkage to medical homes
  - Chest Clinic – TB clinic and field services
  - STD Program – field outreach staff
  - PH Lab
  - Pharmacy – serves indigent, TB program and MH programs
  - Radiology – serves indigent, TB program
  - Dental – serves indigent - mornings only
  - Eligibility
  - Health Care for the Homeless – offices for outreach nurses and admin staff

<p>Public Health Division Update</p>	<p>Olivia Kasirye, MD:</p> <p><b>Ebola Update:</b></p> <ul style="list-style-type: none"> <li>• There was one suspected case in Sacramento County. Test results were negative.</li> <li>• A protocol was put in place to help local schools screen students who had traveled to countries affected by Ebola. So far only one family was screened.</li> </ul> <p><b>Grant Union High School Tuberculosis Update:</b></p> <ul style="list-style-type: none"> <li>• Another round of testing was performed at Grant Union High.</li> <li>• Seeing a significant drop in the percentage of positives from 30% to 14% for students who had attended class in the affected classrooms.</li> <li>• 5% of the general school population tested positive. This number falls in line with general population test results.</li> <li>• A public meeting is being held at the school to address any concerns.</li> </ul> <p><b>STD's Update:</b></p> <ul style="list-style-type: none"> <li>• SDT Stakeholder meeting for September will cover the draft Community Action Plan and continue discussion on getting more stakeholders involved.</li> <li>• For the first time in ten years a newborn tested positive for HIV in Sacramento County.</li> </ul>

Another round of surveys will be presented to the general public for comparison.</li> <li>• PHAB members and guests broke into workgroups to brainstorm answers to four questions presented. Public Comments	<p>Peter Simpson:</p> <ul style="list-style-type: none"><li>• Harm Reduction Services implemented a free training program: “Overdose Rescue for Opiate Overdoses including the administering of Naloxone”.</li><li>• Free kits will be provided that contain two doses of Naloxone.
